



**WASHINGTON STATE FARM LABOR CONTRACTOR VIOLATIONS**

**Updated March 2025**

The Employment Standards Program cited these Farm Labor Contractors for violations under the Farm Labor Contractor Act, [Chapter 19.30 RCW](#).

**This final and binding list of violations dates back to 2018.**

[RCW 19.30.200: Unlicensed farm labor contractors—Liability for services. \(wa.gov\)](#)

Any person who knowingly uses the services of an unlicensed farm labor contractor shall be personally, jointly, and severally liable with the person acting as a farm labor contractor to the same extent and in the same manner as provided in this chapter.

If you use the services of unlicensed farm labor contractors, you may be held liable and receive up to a \$1,000 fine for each violation.
